Letter of Agreement

I understand that my child's composition could be selected for inclusion as part of the *Kids Compose* program, a music program that aims to foster children's natural talent for composing melodies. If selected as a winner, an Indiana University Jacobs School of Music composition student will incorporate my child's composition into an original piece. The final arrangement will be performed at a MCCSC MAC series performance, at which my child will be in attendance for acknowledgement. The performance will be recorded by the IU Jacobs School of Music and be made available digitally.

I am granting *Kids Compose* permission to arrange, orchestrate, record, and reproduce my child's melody as part of a *Kids Compose* project. I understand that as part of this project, there may be multiple arrangements, orchestrations, recordings, and reproductions of the melody.

I also permit *Kids Compose* to copyright the final composition in its own right, in the names of the Jacobs School of Music composer, Indiana University and *Kids Compose*, provided that my child's name is listed as the composer of the original melody.

I may apply for copyright of the original melody only, if I wish. Copyright of the original melody means that no individual or organization, other than *Kids Compose*, will be able to use the melody without my permission. I release all claims to any royalties collected from performances, recordings, and sales of arrangements made as part of this project to *Kids Compose* and the Jacobs School of Music composer.
